### FREE 1<sup>st</sup> Oil Change

You may bring your vehicle to our service department once for your free oil change within the 1<sup>st</sup> 12 months of ownership. Service includes replacement of oil and oil filter, labor to inspect fluid levels, tire pressure and visual wear & tear, exterior lights, and cost of governmental surcharges and sales tax. Service must be performed at James Ford within twelve months of date of vehicle purchase. Any additional repairs or replacement of parts or components will be agreed to and paid by owner of vehicle.

### Money Back Guarantee requirements

- The vehicle must be returned to the dealership within 3 days and with less than 300 miles driven from date of purchase.
- The vehicle has not been damaged or abused and is returned in the exact condition as at time of delivery, at dealer's discretion.
- Any and all equipment that was sold with the vehicle must be returned in the same condition as at time of purchase.
- The refund applies to the vehicle listed on your Retail Purchase/Lease Agreement.
- Any expense you have incurred will not be refunded. This includes gas purchased or any items installed or added to the vehicle.
- There will be a \$295 re-stocking fee to return the vehicle.
- All monies still due and the \$295 restocking fee will be deducted from the refund. If there is no refund due to the customer at time of return, the \$295 restocking fee must be paid in full before return will be accepted.
- If you exchange your vehicle for another vehicle we have in stock, the \$295 restocking fee will be waived.
