

# MITSUBISHI MOTORS REBATE REIMBURSEMENT FORM FOR TRADE-IN ASSISTANCE PROGRAM

Mitsubishi Motors North America, Inc. (MMNA) will reimburse as outlined in Mitsubishi's "TRADE-IN ASSISTANCE REBATE PROGRAM" Official Rules, to the retail customer or the retail customer's dealership designee upon the retail sale or lease (if applicable) of an eligible vehicle a rebate as outlined in the official Program rules.

*Submit this completed form along with a copy of the following documents and maintain copies for audit purposes.*

1. The signed purchase agreement (Mitsubishi Motors Trade-in Assistance rebate amount listed as a separate line item if the customer chooses to apply the amount as a down payment).
2. The Mitsubishi motors factory invoice.
3. The Motor Vehicle registration or title certificate currently registered to (i) the purchaser, or (ii) a family member, or a domestic partner of a currently registered owner of a Mitsubishi vehicle living at the same physical address as the purchaser.
4. If the purchaser is not the current registered owner, provide a photocopy of the drivers license of both the purchaser and registered owner. Both drivers licenses must show the same physical address.
5. Trade-in Assistance rebate may not be combined with Loyalty Program or any VIP or Employee Programs.

**This form must be submitted within 10 working days of retail purchase or lease to be eligible for payment.**
